2015 Competitions Update

Subsequent to a meeting of Rugby Europe's Executive Committee today, this second Competitions Update serves to provide you with absolute clarity regarding this year's events.

For Seven a side Rugby in Europe, 2015 represents a hugely important year. With all Rugby Europe Senior Sevens Tournaments forming part of the Olympic qualification process, the eyes of the Rugby world will be upon us and the profile of our competitions will be significantly enhanced. It is important that we capitalise on this together and that everyone involved, players, team management, officials, works together to deliver the best product.

May I remind all Unions that the Executive Committee of Rugby Europe sanctioned the creation of a Competitions Review Working Group which is tasked with analysing current competition structures to assess their suitability to the development and performance needs of Member Unions and to do so in a way that it financially sustainable, commercially viable and helps to increase the profile of Rugby Europe and its stakeholders.

This Working Group meets once a month and is due to provide a report and recommendations to the Executive Committee in 2015.

On the next page you will find a schedule of all annual Rugby Europe Competitions including dates, participants and hosts, as approved by the Executive Committee of Rugby Europe. In one or two cases, some details require refinement however, it is hoped that the information provided, as approved by the Executive Committee, allows you to prepare for the year ahead.

Rationale

The model proposed sees all teams taking part in shortened matches lasting 35 minutes (17 mins 30 seconds per half)

Teams will only be required to play one of these matches per day however, on occasion, they will be required to play matches on consecutive days, without a rest day.

That said, this only represents 70 minutes of competitive rugby over 2 days thus alleviating major concerns relating to player welfare. Further, with all matches scheduled to take place in the evening time, teams have 2 hours of recovery before playing their next match.

The format allows all teams to play against one another, maintaining the integrity of the competition. It provides an important opportunity at this level, for teams to play against other styles of rugby and to benefit from the touring and international competition experience. There are opportunities for interaction between teams and the possibility of carrying out some Training and Education workshops.

This competition will be played on a World Rugby Reg 22 approved artificial surface.



Under 17 Cross Border Competition

This initiative will not take place in 2015.

Under 15 / 17 Camps

Rugby Europe's Executive Committee has confirmed the withdrawal of funding from this initiative.

It is the view of the Committee, after consultation with World Rugby, that in the event Unions see significant benefits in hosting and participating in U15/17 camps, this initiative is better served by being driven by Member Unions according to their needs and means and funded by Unions through the World Rugby development grants with the support and assistance of the World Rugby Regional Development Managers.

Women's European Trophy – 15 a side Geneva or Zug (TBC), Switzerland 28 October – 1 November 2015

This competition is proposed to take place in the same 'window' as in 2014. It is proposed that a 4 team tournament take place once again, including the teams from 2014.

Seven a Side Competitions - Senior

It should be noted that all SENIOR Seven a side competitions in 2015, for Men and Women form part of the Olympic Qualification process. This includes the Men's and Women's Grand Prix Series, Divisions A & B and Men's Division C.

As a result, all teams will be subject to the Olympic Eligibility criteria contained within World Rugby's Regulation 8. Unions are requested to read and understand these Regulations in their entirety.

The highest eligible country which has not prequalified through the HSBC Sevens World Series, will qualify directly to the Olympic Games

The second country who has not prequalified through the HSBC Sevens World Series, will qualify directly to the World Rugby Global Repechage Tournament in 2016.

All other eligible SGPS countries will qualify for the Rugby Europe Olympic Repechage Tournament (EORT) on 25 /26 July 2015.

The Winner and Runner up in Division B will be promoted to Division A and will be Seeded 11th and 12th respectively for the 2016 Division A competition

The Teams finishing in 11th and 12th place will be relegated to Division C and seeded in 1st and 2nd place respectively for the Division C Tournament in 2016.

In the event that Rugby Europe reverts to a regionalised Division B tournament to replace Division C, the 11th and 12th ranked teams from Division B will be appropriately allocated and Seeded accordingly.

Men's Division B - Olympic Qualification

The highest ranked eligible team from Division B qualifies to participate in the Rugby Europe Olympic Repechage Tournament (EORT).

This is with the exception of Slovakia who are not a Member Union of World Rugby.

Greece's membership of World Rugby is currently under suspension thus unless this is reversed by 20 June, Greece will also be considered ineligible to qualify to EORT.

- In order to create a 12 team Tournament, Division C top seeds Greece, have been promoted to Division B as 8th seed with all teams in Division C moving up one ranking place.
- The top two teams in Division C will be promoted to Division B and compete in the 2016 Division B tournament

Olympic Qualification

- Only Full and Associate Members of World Rugby may qualify for the 2016 Olympic Games in Rio.
- Whilst acknowledging that the 2015 Senior Sevens tournaments form part of the Olympic qualification process, they are also annual Rugby Europe events.
- The Olympic Process will see the four highest ranked World Rugby Full and Associate Members from Division C qualifying to play in the next phase of qualification; Division B in Zagreb on 20 / 21 June, 2015.

Hypothetical Example – Olympic Qualification

- Referring to the table above, World Rugby Full Members are marked with an asterisk (*).
- If this table was to represent the final ranking positions after the Division C tournament, then the four teams who are eligible to qualify for the next phase (Division B) would be Bosnia, Serbia, Austria and Ireland.

Promotion Process for 2016 Rugby Europe Competitions

- In normal, non Olympic qualifying years, the top two teams are promoted to Division B.
- In order to ensure the integrity of Rugby Europe competitions year on year, the top two ranked Rugby Europe teams be promoted to Division B for 2016, regardless of whether they are Full or Associate Members of World Rugby.

5 Unions have expressed an interest in hosting one or both of these Repechage Tournaments. These Unions have received a tender document. After due process is observed, the Rugby Europe Executive Committee will appoint a host or hosts of these Tournaments in late February.

The make up of the teams competing in the Men's and Women's European Olympic Qualifier cannot be known at this time.

However, we can be sure that it will include all teams from the Men's and Women's Sevens Grand Prix Series who have not pre-qualified through the HSBC Sevens World Series or by winning the Men's or Women's Sevens Grand Prix Series.

The number of SGPS and WSGPS teams to qualify for the European Qualifying Tournament will have a bearing on the number of teams who qualify from Division A. In both the Men's and Women's Qualification process, the winner of Division B will be afforded a place in the European Qualifying Tournament.

Eligibility Criteria to be observed for the European Olympic Qualification Process

I was requested during the Rugby Europe General Assembly to provide a note to assist the interpretation of World Rugby regulation 8 for Rugby Europe members for our Tournaments that fall into the Olympic Qualification process for Rio 2016.

Firstly I wish to clarify that all Division C,B, A and SGPS Tournaments for both Men and Women are Olympic Events as they are part of the European Olympic Qualification Tournament structure. As such all Participating Countries in our 2015 Rugby Europe Tournaments must adhere to the Regulation 8 eligibility regulations as adapted for Olympic Events.

In this regard Regulation 8 requires that Players must comply with clause 8.1 (the standard criteria of eligibility). Clause 8.6 requires that all Players must <u>additionally</u> be a National of the Country of the participating Union as demonstrated by being a passport holder.

Clause 8.7 identifies a process allowed by the Olympic Charter whereby players may transfer between Countries, with clause 8.7.2 identifying the permitted stand down period required under Regulation 8.

This note is for guidance and should not be read in isolation. Please read and understand World Rugby Regulation 8 and the associated guidance notes as this is the document to which all Unions must adhere. Should you have any queries arising from this, please follow the processes for clarification identified within the World Rugby Regulations.
